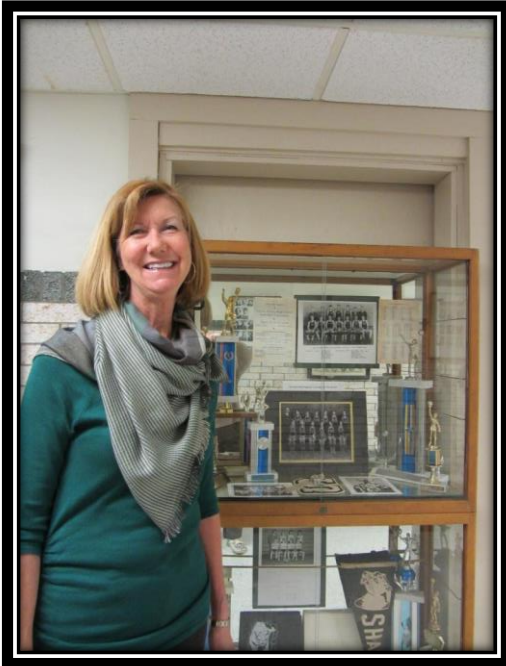

Growth of SCCA Membership

As we approach the 12th anniversary of the Shade Community Center Association this spring, I thought it would be interesting to examine how our membership has changed. Over the past couple of years, membership in the SCCA has grown significantly from a low period in 2012-2013. The total number of members, as well as the number of living life members at the end of each year, is shown in the chart below:



Entering 2017, the total number of members is 272, nearly as great as in 2008 and 2011. The surge in 2008 to the all-time high of 278 followed the Play in Shade project to build the ball field and walking path. The relative highs in 2010 and 2011 followed pushes to get annual members to renew. Every year at least thirty members from the previous year do not renew for one reason or another. Sometimes the number that do not renew is much higher; for example, 76 did not renew in 2012.

The increases the past couple years are likely related in large part to decreasing the membership dues to residents of Lodi Township to half the usual rate and mailing the first newsletter of the year to all residents of the township. In 2015 over five hundred extra newsletters were sent to those who lived in Lodi, resulting in 19 new memberships and 36 new members as well as nearly twenty former members returning. Each year much of the decrease in renewals from the previous year is compensated by those who return after a lapse of a year or so. (Note: the figures that I gave to the incoming Corresponding Secretary for reporting at the January meeting, which showed only a slight increase from 2015 to 2016, were in error because I had inadvertently counted most of those members from 2014 who did not renew as members during 2015.)

Unfortunately, membership records for 2005, the first year of the SCCA, could not be located. Interestingly, however, review of minutes of meetings during the first year showed that 76 different people attended one or more monthly meetings during that year when the organization was getting started!

It is remarkable that the total number of members has stayed as high as it has when one remembers that sixty-three (63) of our members were deceased while their memberships were current. Several others passed after their memberships had lapsed a few years. Sixteen (16) of our deceased members were life members. Still, the total number of life members has remained relatively constant. Only five life memberships have been received since 2008 and only one since 2010, even though the life membership dues have remained constant at \$500.

SCCA December 14, 2016 Meeting Minutes (APPROVED 1-11-17)

39 members present: 39 members+ 8 officers/board

The regular monthly meeting of the Shade Community Center Association was held on Wednesday, December 14th at 7:10 pm, in the Shade Community Center cafeteria, President Pat Davidson being in the chair and Recording Secretary Gail Jordan being present.

Minutes of the November 9, 2016 regular meeting and the November 29, 2016 Executive Committee meeting were distributed by Gail Jordan for reading. Fran Moxley moved for approval of the regular meeting minutes as amended; minutes approved. Fran moved for approval of the executive committee meeting minutes as written; minutes approved.

Treasurer Alex Couladis reported net income for November of \$4,357.93. Final levy payment of \$7866 had been received from the Lodi Township trustees, bringing total for the year to \$18,544. Remaining Coen bequest funds, in addition to those invested, total \$16,020.62.

Maintenance committee report was distributed by Gail Jordan and placed on file. Major items noted: Jerry Foster had installed new grill in kitchen and done major cleaning of the range. Water pressure was increased to improve automatic flushing in the women's restroom.

Old Business: Fran Moxley distributed the final revisions of the constitution and by-laws and the Standing Rules. Frank Cargould moved for approval of both documents. Motion carried with no negative votes, although there were several abstentions.

New Business: Nominating committee distributed ballots for election of SCCA officers for 2017. Elected were: Jerry Foster, President; George Benz, Vice President; Gail Jordan, Recording Secretary; Brenda Dorst, Corresponding Secretary; and Alex Couladis, Treasurer.

Pat announced that Rhonda Meeks had agreed to return as editor of the newsletter. Several people volunteered to help Rhonda with pickup, applying address labels and stamps, and mailing each issue.

Gail noted that the second memorial plaque was now filled. Fran Moxley moved to purchase another one; motion carried.

Fran suggested that John and Esther Scragg be allowed to use the cafeteria rent free on Christmas day since they had volunteered as Mr. and Mrs. Santa Claus at the Breakfast with Santa and Holiday Bazaar. Tammy Foster moved for approval of this suggestion; motion carried.

Fran said that Kate Fleming had expressed interest in renting the front rooms on the third floor for \$50 per month. Peggy Rist moved that this be tried on a month-to-month basis subject to review after three months. Motion carried, with some negative votes and abstentions.

Tammy Foster reported net income from the November fish fry of \$253.31 (\$433.00 income less \$179.69 expenses). Tammy also reported 50-60 kids and parents attended the Breakfast with Santa. Net income from the Breakfast with Santa and Holiday Bazaar was \$639.09 (donations of \$555.85 less \$396.76 expenses for Breakfast with Santa, plus \$480 income for rented spaces at the bazaar).

Heidi Marty requested having a community New Year's Eve party on December 31st and announced the joint SCCA/SSCA New Year party/potluck on Saturday, January 7th beginning at 5:30 pm.

SCCA January 11, 2017 Meeting Minutes (APPROVED 2-8-17)

20 members present: 13 members+ 7 officers/board

The regular monthly meeting of the Shade Community Center Association was held on Wednesday, January 11th. Past Vice President, Fran Moxley, called the meeting to order at 7:00 pm in the Shade Community Center cafeteria. Following the pledge of allegiance, officers for 2017 who were present were installed: Jerry Foster, President; George Benz, Vice President; Gail Jordan, Recording Secretary; Brenda Dorst, Corresponding Secretary.

Minutes of the December 14, 2016 meeting were distributed by Gail Jordan for reading. Tammy Foster moved for approval as written; minutes approved.

Jerry Foster distributed and summarized the reports that Treasurer Alex Couladis had prepared for December 2016 and calendar year 2016. Net income for December was -\$1218.10. Net income for the year was \$824.59 after adjustments for transfers from the Coen bequest and for levy funds received to pay utilities to April. Checking account balance was \$21,939.57. Remaining Coen bequest funds, besides those invested, total \$16,027.20. Reports were filed for financial review.

Fran Moxley distributed calendars for January and February, noting no history meetings during January or February. Brenda Dorst read Corresponding Secretary's report, noting: get well card sent to Fred Colburn, sympathy cards sent to Linda & Jim King and Lois Bigley, and thank you sent to John and Esther Scragg. She also noted that at the end of 2016 SCCA had 226 annual and 45 living lifetime members for a total of 271; 9 renewals had been received for 2017.

Maintenance committee reported one main item: lines had been run and eight security cameras had been mounted. Fran Moxley moved that the maintenance committee contact someone of their choice (Heidi Marty suggested Joe Church of Quality Sales & Service) to evaluate both copiers and estimate repair costs, authorizing repairs up to \$250, but if that amount was exceeded to bring up again at the next meeting. Motion carried with no negative votes.

Old Business: Heidi reported on the New Year's Eve party and said that she had pictures for the newsletter. Pat Davidson said about twenty people attended the holiday potluck.

New Business: First meeting of the events committee was announced for Monday, January 16th at 6:00 pm. Heidi Marty, George Benz, Fran Moxley, Brenda Ruth, and Marvin Marty volunteered to serve on a committee to propose a budget for 2017. Pat Davidson, Gail Jordan, and Bev Guider volunteered for the 2016 financial review committee.

Following major discussion of the possibility of obtaining an annual food permit, Marvin Marty moved to do so. Five affirmative votes, eight negative votes, motion failed to pass.

Valentine's Dinner will be Saturday, February 18th beginning at 6:00 pm. Times on the Thursday and Friday before for set up and decorating are yet to be determined.

Tammy Foster announced that the Athens Health Department was offering a class for pre-diabetics, which was free for those preregistering. Advertising boards were briefly discussed, but no action was taken.

Jerry Foster announced that Amy Calvert and Norm Shaner have accepted appointments to the Executive Board for 2017. He also announced tentative dates for board meetings: January 25th, April 26th, July 26th, October 25th. Jerry noted that ideas/comment forms were on the table in the rear of the cafeteria and requested these be submitted to him for consideration by the Executive Board.

Baked Green Bean and Onion Supreme

Here's What You Need

2-1 lb frozen green beans	2 medium onions, sliced
8 Tbs butter	4 Tbs flour
1 tsp salt	½ tsp pepper
2 Tbs coriander	1 tsp grated lemon peel
8 slices bacon, crisp & crusted	16 oz sour cream
1 C sharp cheddar cheese, shredded	6 oz V-8 juice
1 C bread crumbs	

Here's What You Do

Steam green beans. Cook onions in 4 Tbs butter until tender. Add flour, salt & pepper, lemon peel & coriander. Cook & stir until bubbles. Stir together beans, bacon & V-8. Turn into 8 x 11.5 x 2 dish & bake at 375 degrees for 20 minutes. Top with sour cream & cheese. Combine 4 Tbs butter & bread crumbs. Top. Reheat & melt cheese.
