Lyle and Suzanne Wolding's Cabin



Wolding's Cabin - a Washington County log cabin that found a new home in Lodi Township

The tour of the Wolding Cabin began with Lyle describing its history. Lyle had a lifelong wish to restore a historical building. This dream came alive when he arrived in Ohio and found he admired the values he encountered. Lyle and Suzanne found property in Lodi Township, formerly owned by Pat and Joe Davidson, and named it Spring Ridge Farm. Lyle learned of a cabin for sale in Washington County, Ohio on Township Road 61, close to the old Henry Bridge, with the Goddard property close by. When they arrived at the site, all they saw was what looked like an old 7-room house. Lyle asked, "Where is the log cabin?" and was told it was under the siding.

The cabin may date as far back as 1780. They have seen the Goddard deed which dates to 1810. Other names associated with the cabin are James Foreman, Eliza James, and the Harris Family. Lyle speculated, because of the association with Eliza James, that this cabin may have been 'the' Uncle Tom's Cabin, but further investigation is necessary. Several Cutler residents attended the meeting, including Harris Family descendants. Mike Brant, from Cutler, gave Lyle some very interesting information, that he was told this log cabin came from Fort Harmar, a fortress which was built in 1785.

The Howard family helped Lyle take on this laborious project. The cabin took 3 plus years to disassemble, relocate and restore. One horrendous story was when one of the workers pulled down the siding and many many snakes fell out. "OH, MY." The logs are poplar and chestnut oak. Two thirds of the floor planking came from a school in New Philadelphia. The stones in front were relocated from the Pratt's Fork Church on Slab Road.

Lyle and Suzanne are happy residents of Lodi Township and they "love it here!"

November, 2014 Meeting Minutes

- Pledge of Allegiance was led by Pat Davidson
- The minutes of the October meeting were reviewed. Ray moved that the minutes be approved as corrected.
- Alex presented the treasurer's report. The checking account holds \$15,164.40; this does not include the \$25,000 bequest funds set aside for renovation.
- Fran reported that as corresponding secretary, she would send condolences to the Kathy Dillinger-Essman Family. The use of the center had been offered for a meal after the funeral, but other arrangements had been made for the family. A motion to send a meat/cheese tray (limit of \$50) was made by Grace, seconded by Heidi, motion passed. Heidi will deliver the tray. Thank you cards would be sent to Lauren Miller for books donated to the library, as well as to the Athens Library for VHS tapes donated.
- Peggy distributed the calendar of events for the months of November and December. Additions and edits were made.
- The maintenance report came by way of e-mail from Gail.
 - Repair to the boiler, the spare pump was stuck.
 - The yard had been mowed for the final time, battery removed from the mower.
 - Doors are in the process of rekeying.
- There was no History report
- The Senior's group reported that the dinner to honor Veterans went very well, though there was not as many in attendance as in previous years. The ROTC Color Guard assisted with the opening ceremony.
- It was noted that the door replacement project was complete. The contractor, Hoon, will be paid right away.
- Distribution of the revised By-Laws was made by Marvin. The Standing Rules have not been made available for distribution.
- The committee for proposed updates of the rental agreement had little to report. They are waiting for other non-profit organizations to share similar documents to give guidance for possible revisions. They hope to have a preliminary draft at the December meeting.
- Ray turned in an additional \$95 for Jerseyville apple butter sold.
- Jerry reported that the Halloween Party profited approximately \$592 this year.
- The Holiday Bazaar will be December 6 with set up December 5. Volunteers are needed for the kitchen crew.
 - Breakfast with Santa chaired by Rhonda will be 9-11:30 a.m.
 - After much discussion about the cost of the breakfast to the center, Teresa moved that \$200 be budgeted for this, Norm seconded, motion passed.
 - The committee is suggesting a donation of canned goods by children/families that will be given to the local food pantry.
 - Volunteers also needed for this event.
- Teresa volunteered to man a table to sell the cookbooks at the Alexander Holiday Bazaar. The cost for the table space would be \$10. Fran moved that we do this, Roberta seconded the motion. Motion carried.
- The Alexander Youth Wrestling will begin practices on Monday and Wednesday evenings. Schedule of the meets will be available mid-December.
- A request for volunteer labor to build a ramp for entry for community members Pat and Alan Rankin was made.
- Left over soup beans from the Jerseyville Festival were given to the Athens Church of Christ, the donation was much appreciated.
- A motion to adjourn was made by Fran, seconded by Alex, motion carried.

December 10, 2014 Meeting Minutes - Draft

- Pat Davidson led the Pledge of Allegiance
- The minutes of the November meeting were reviewed. Ray moved that the minutes be accepted as corrected, Marvin seconded the motion, all in favor.
- Fran reported that sympathy cards were sent to the Dillinger-Essman families, as well as thank you cards for various donations to the Center. She shared a card from Lois Swartz Bigley, praising the SCCA Cookbook and offered to contribute more recipes from Lodi cooks that have passed on if there is a future edition.
- Fran also shared that 60+ cook books have been sold to date.
- Alex presented the Treasurer's report. Year end is showing us with \$14,172.22 in the checking account, roughly \$52,000 in the savings account and \$100,000 in investments. We are currently showing an \$8000 loss for the January-November 2014 period. Hoon contractors have been paid for the installation of new doors. Ray moved to accept the report, Robin gave a second, motion carried.
- Peggy Rist circulated the event calendar for December and January. Edits and additions were made.
- Gail's presented a maintenance report via e-mail:
 - Alexander Youth Wrestling submitted their schedule for December, Home meets 12/18 and 12/22, volunteers for the concessions is needed.
 - Updated 2015 membership forms ready for review. (The only edit was to place an * before "According to current bylaws..." as reference to the different membership categories and amounts. Fran moved to accept the form as amended, Teresa seconded, motion carried.)
 - Athens Lock and Key has changed locks on the 4 rear doors, replaced cylinder on left set of front doors.
 - Jerseyville cornstalks have been taken down, but not hauled off yet.
 - 15 furnace filters replaced, 10 horsepower motor oiled and big blower greased.
 - Boiler system issues, motor on pump #1 will not turn, #2 pumps is all that is presently working, we have no spare motor.
 - Manuel is modifying the closers for the stairwell gates
 - Sign at the front of the center suffered wind damage
- Teresa moved that we contact the Jackson boiler repair folks that have previously serviced the boilers to evaluate the situation, Fran seconded the motion. Motion carried.
- Teresa also mentioned that the single back door to the gym was very difficult to lock on Tuesday; she had trouble getting her key out of the lock.
- Manuel shared that the History group would be having their Christmas potluck on December 16, at 6:30.
- Jerry will check with Performance Signs to see what the cost will be to repair the signs damaged by the wind.
- There was no report from the seniors – December meeting will be the 11th at 7:00 p.m.
- Jerry and Tammy reported that the Holiday Bazaar had 29 vendors with \$412.50 collected for space rental. \$635.09 was the net profit after kitchen expenses and The Messenger ad.
- Rhonda reported that we served 60 children plus parents at the Breakfast with Santa event.
 - 3 boxes of nonperishable goods were collected for Ray to deliver to the Coolville Food Pantry.
 - Rhonda asked permission to leave the Christmas decorations covered in the carpeted room on the second floor rather than dismantle and store away. It was the consensus of the group to not do that as the decorations would not be secure.
 - Rhonda also suggested that SCCA purchase a \$25.00 gift card to present to Mr. & Mrs. Scraggs aka Mr. & Mrs. Clause. Tammy moved to purchase the \$25.00 (plus activation fee) gift card, Rhonda seconded, all in favor.
- The Holiday Potluck will be 12/13/14 at 5:30. Janet Bell is preparing a ham on behalf of the Senior group, Fran is cooking a turkey for SCCA, Roberta is preparing scalloped potatoes and Tammy will cook noodles that were purchased for the Jerseyville Festival. All attending are asked to bring a covered dish to share, and perhaps a nonperishable food item for donation to the local food pantry.
- Heidi passed out the updated version of the Standing Rules
- The deadline for submission for the next newsletter is December 19th, 2014.
- Election of officers was held. There were 24 voting members present. New officers for the 2015 year are Marvin Marty, President; Peggy Rist, Vice President; Pat Davidson Recording Secretary; Alex Couladis, Treasurer; Heidi Marty, Corresponding Secretary. The new officers will be sworn in at the January 2015 meeting.
- Jerry brought to the floor that he had been approached by someone interested in renting the whole 2nd floor space to be used as an antique mall. After some discussion, it was general consensus that it would not be a good fit for the Center.
- Ray reported that several of the jars of apple butter that he had taken to sell had bad seals and the contents had evidence of mold.
- Ray moved that the meeting be adjourned, Robin seconded, all in favor.


