Renovations Thanks to Mrs. Coen's Bequest

We continue to appreciate and value the generous support of Mrs. Coen, through her bequest to the Center. Work continues on modernizing the kitchen and making it as efficient and attractive as we can. Two more movable drawer units will be delivered by the end of October, then we'll re-group and decide what's next on our wish list--ceiling repair? painting and replacing baseboard? replacing curtains with window shades? We're in the "attractive" stage of this project now. It was a pleasure to use the new equipment and arrangements during the Jerseyville Festival!

Cause for celebration--we have replaced the front doors, the transom units above them, the door to the furnace/boiler room, and the front door into the cafeteria. All the new doors have sweeps to help keep out drafts and rain and locks have been updated. The contractor, Hoon Inc., was able to salvage the transom units above the old doors; one will be put on display somewhere in the Center, and the other will be dismantled and the individual, diamond-shaped glass panes will be used for door prizes at the Alumni Banquet next spring. As a result of this project, we look forward to reduced heating bills this winter, and to increased security throughout the coming years, all thanks to Mrs. Coen's bequest.

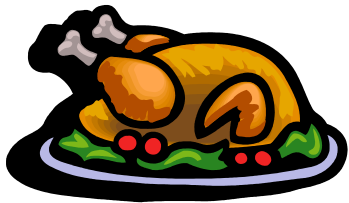
Special SCCA Gifts for Christmas

- The door replacement project is to begin this week (September 10-?).
- Distribution of the revised By-Laws and Standing rules was tabled until October.

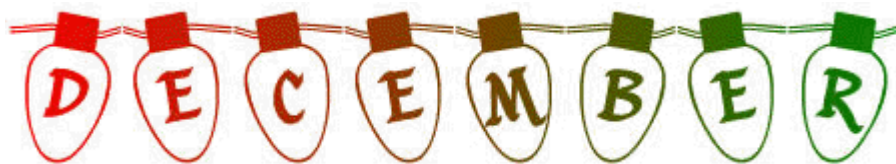
October, 2014 Meeting Minutes - Draft

- Pledge of allegiance led by Pat
- Minutes of the September meeting were reviewed. Fran moved that they be approved as submitted, Rhonda seconded the motion, the motion carried.
- Alex presented the treasurer's report. The checking account balance is \$12,830. The remainder of the Coen bequest money has been set aside to cover the expenses of current renovations, the kitchen project and new exterior doors.
- Corresponding secretary, Fran said there had been little activity for the month.
- V.P. Peggy reported several reservations for the use of the building over the next several weeks. Additions and edits to the calendar came from the floor.
- Maintenance committee reported much activity in preparation for the Jerseyville festival, including painting of benches, railings, doors; mowing, trimming, spraying, mulching and concrete patching.
- History group reported that the auto tour was a success. They are currently planning the dinner to honor area Veterans, Saturday, November 8, 2014.
- Fran reported that the cookbooks are finished, several were sold at the Festival (price \$10.00). She said she had received requests for purchase by mail. For \$2.00 extra, the book can be mailed.

- Distribution of the revised By Laws and Standing Rules has been pushed back until the November meeting.
- The review of the rental agreement will take place at the November meeting. Committee for updating the agreement includes Teresa Winning, Robin Krivesti, Peggy Rist, and Heidi Marty. Fran will type the agreement for presentation.
- Jerry Foster gave a preliminary report for the Jerseyville festival. Roughly, \$3000 profit this year. Members felt this was very good considering the adverse weather on festival day.
- The nominating committee for officers for the 2015 year reported the candidates: Marvin Marty, President; Peggy Rist, V.P.; Pat Davidson, Recording Secretary; Alex Couladis, Treasurer. Robin nominated Heidi Marty as Corresponding Secretary, Heidi accepted the nomination.
