# Veteran's Day





### Frozen Bubbles

Snow Candy was a traditional treat back in the 1800s and was probably a favorite of children in Jerseyville.

#### **Molasses Snow Candy**

- 1/2 cup butter
- 2 cup brown sugar
- 4 TAB molasses
- 1/2 teas vanilla
- 2 TAB water
- 2 TAB vinegar

#### **Maple Snow Candy**

1 cup real maple syrup 1/4 cup butter

Add all ingredients from **one** of the above snow candy recipes to a stock pot and bring to a boil over medium-high heat. Boil until you have a soft ball stage (240 F) for chewy candy or hard ball stage (310 F) for hard candy ideal for sucking on or crunching.

Now comes the fun part. Pour the candy on clean, fresh snow that is at least 2" thick. The candy will sink down ever so slightly (less than 1/2") into the snow.

Pick up and enjoy!



#### Have you tried blowing frozen bubbles?

This winter, when it is REALLY COLD (below zero), try blowing bubbles outside. It's mesmerizing and like watching Jack Frost paint on a mini snowglobe. Each bubble has its own unique crystalline pattern.



#### How to Blow Frozen Bubbles

Go outside when the temperature is below freezing 32 degrees F. The colder the better. Allow your bubble solution to cool before blowing bubbles. Find a place outside that is cold and protected from the wind.

- 1. Dip a bubble wand in the "bubble juice". Blow a bubble and catch it on the bubble wand. Wait!
- 2. Dip a straw in the "bubble juice". Carefully move the straw on top of a flat surface, like a plate. Gently blow a bubble. Wait!

#### **Bubble Juice**

Mix up water and baby shampoo, or any liquid soap, in a large bucket or dish.

#### SCCA October 12, 2016 Meeting Minutes (FINAL, APPROVED 11-14-16)

Members present: Pat Davidson (P), Fran Moxley (VP), Gail Jordan (Rec. Sec.), Marvin Marty (PP), Frank Cargould (BM), Walter & Karen Jones, Heidi Marty, Brenda Ruth, Tammy & Jerry Foster, Grace Dorst, Manuel Grueser, Peggy Rist, Tere Sager, Robin Krivesti

(11 members+ 5 officers/board = 16)

The regular monthly meeting of the Shade Community Center Association was held on Wednesday, October 12, at 7:11 pm, in the Shade Community Center cafeteria, President Pat Davidson being in the chair and Recording Secretary Gail Jordan being present.

Minutes of the September 14, 2016 regular meeting and of the September 27, 2016 executive board meeting were distributed by Gail Jordan for reading. Marvin Marty moved for approval of both as written. Minutes approved.

Pat Davidson distributed Treasurer's reports that Alex Couladis had prepared: Net income shown for September was -\$2593.90, and year-to-date was approximately -\$600 taking into account expenses paid from the Coen bequest. Second half utility reimbursement from the township trustees had yet to be received.

Maintenance committee report was distributed by Gail Jordan and placed on file. Major items noted: fire inspector Jim Malone from Lancaster approved the Ansul suppression system in the kitchen and re-tagged all fire extinguishers for another year. Kitchen storage room lock has been changed and is now locked when not in use. Recycling containers were relocated to near shelter house entrance; Pat Davidson noted concerns of neighbor Kaylee Stotts.

Fran Moxley distributed calendars for October and November, noting Monday dates of "Shade Cooks" Live Healthy Appalachia cooking class.

Old Business: Regarding OU Archery Club request to practice, Pat reported she had been sent copy of their insurance certificates. Possibilities of rental fee and of storage of their equipment on site were discussed. George Benz volunteered to open for group if they practice inside.

Karen Jones gave nominating committee report: As of meeting Marvin Marty agreed to run for President, and Alex Couladis agreed to run for Treasurer. Brenda Dorst was considering Corresponding Secretary, and George Benz was considering Vice President. They had no candidate for Recording Secretary. Jerry Foster nominated from the floor Gail Jordan and Walter Jones for President and/or Vice President but both declined the nominations. Others can volunteer to run until October 31<sup>st</sup>, with short bios due for the next newsletter by November 1<sup>st</sup>.

Discussion of proposed revisions to Constitution and By-laws was postponed until the November meeting.

The regular monthly meeting of the Shade Community Center Association was held on Wednesday, November 9, at 7:10 pm, in the Shade Community Center cafeteria, President Pat Davidson being in the chair and Recording Secretary Gail Jordan being present.

Minutes of the October 12, 2016 regular meeting were distributed by Gail Jordan for reading. Ray Baker moved for approval as written. Minutes approved.

Pat Davidson reported a balance of \$18,069.89 in the checking account and a positive net income for the month of over \$3000. (The detailed reports that Treasurer Alex Couladis had prepared were not presented as they did not make it to the meeting; these were distributed at the Executive Committee meeting later in the month, and the actual net income for the month was \$3,442.54.)

Maintenance committee report was distributed by Gail Jordan and placed on file. Major items noted: Jerry Foster described problems ordering the security camera system. Gail noted that boiler and furnace systems had been readied for season and put into service. Jerry Foster moved to get information on cost of bearing for 10 hp circulation fan motor and/or cost of replacing the motor. Motion carried.

<u>Old Business:</u> Nominating committee announced candidates for 2017 SCCA officers: President, Marvin Marty and Jerry Foster; Vice President, George Benz; Recording Secretary, Gail Jordan; Corresponding Secretary, Brenda Dorst; Treasurer, Alex Couladis.

Gail Jordan summarized findings and recommendations of the financial review committee, which had completed review of bank statements and monthly reports. Following discussion, Robin Krivesti moved that recommendations be forwarded to the executive committee and discussed with the treasurer; motion carried.

Fran Moxley presented proposed revisions to Standing Rules and Constitution and By-Laws. Discussion of standing rules primarily was about issue of long-term rentals, with need to include process to be followed. Several items were discussed regarding the by-laws, related to nominations of officers and preservation of records. Fran is to incorporate these and present the revisions for approval at a future meeting.

Jerry Foster reported net income from Jerseyville Festival of \$2811.79 (\$6844.57 income less \$4032.78 expenses). Fran Moxley noted that 74 dinners on Sunday brought in nearly \$1000. Fran reported that the retired teachers' luncheon on November 2nd had net income of \$146.16 (\$250 donation less \$103.84 expenses). Tammy Foster reported that about 300 people attended the Halloween party and net income was \$202.78 (\$852.65 income less \$649.87 expenses). (At the December meeting Alex Couladis noted that income from the Halloween party was \$332 after additional donations were received.)

New Business: New editor for newsletter was tabled until December meeting.

Custodian: Initial work of new custodian Jennifer Pae and communications with her were discussed. Pat was to have Jennifer sign an agreement to formalize the position.

Financial Review Report: The summaries of the review committee were discussed point by point. Fran offered assistance with organizing reimbursement forms and receipts. In addition to requiring reimbursement forms for all reimbursements, recommendations included: 1) adding a "category" column to the reimbursement form, and 2) creating and requiring a similar form for submittal of credit card receipts.


