## Ada Woodson Adams

The Shade-Lodi History and Genealogy Association program for March, 2014 was Ada Woodson Adams' presentation on Albany's Past and the Underground Railroad. Ada was born in Nelsonville, Ohio and is a graduate of Ohio University. She is co-founder and President of the Multicultural Genealogical Center in Chesterhill, Ohio. Ada is a descendent of Thomas Jefferson through the Woodson's of Jackson County Ohio. She co-authored the book: [A Significant Presence: A Pictorial Glimpse of the Black Experience in Athens County Ohio.](#)

Albany, a rural town in Athens County Ohio, was founded in 1842. In Albany the positive atmosphere for education became motivation for blacks to settle there. The Lewis Academy founded in 1847 by William Lewis had no admission restrictions. Later, The Albany Manual Labor Academy, allowed both girls and boys of all races to attend. But, the Civil War caused the loss of students and it was closed. In 1862, the Christian Church bought the school, changed it to Franklin College and excluded blacks. Because of this, the first black-owned and operated school in the United States, called Albany Enterprise Academy, was built. At one time there were over one hundred students. The two story building was constructed in 1864 and continued operational until 1886 when Thomas J. Ferguson resigned, blacks migrated to big cities and public schools were integrated.

Albany was an Underground Railroad stop because of its proximity to the Hocking River. Underground Railroad is a term used to describe the escape routes from the captivity of slavery to freedom in the north. The Underground Railroad was a necessity because of the divided society in the New World, of those for the slavery of black persons and those against slavery. Slavery is a barbaric system where people "are treated as property to be bought and sold, and are forced to work. Slaves can be held against their will. Slavery is officially illegal in all countries, but there are still an estimated 20 to 30 million slaves worldwide." (Wikipedia, 2014) There were 11 states that believed in slavery and some of the black population chose to escape. One of the places chosen was Albany because it was considered a safe haven to runaway slaves or as Ada calls them "Freedom Seekers". One of the conductors of the Underground Railroad in Albany was Dr. Chapman Cline. He would take the Freedom Seekers to Albany Mayor John Austen Brown's general store located at the corner of Washington and West Clinton Streets. Doug Hooper, a resident of Albany, was a conductor, meaning one who led them on their journey to freedom. White's Mill in Athens was also one of the safe houses.

Ada Woodson Adam's ancestor, Sarah Woodson Early, was an educator and a Temperance advocate and also the granddaughter of Thomas Jefferson and his slave Sally Hemings. Sarah lived at Berlin Cross Roads in Jackson County, attended the Albany Academy and later graduated from Oberlin College in 1856.

Ada invited all to attend the Multicultural Genealogical Center's meetings held at the Center on the corner of Routes 377 and 555 in Chesterhill, Ohio on the first Saturday of each month at 1pm. ## The first installment of Bob Steele and the Shade Biddy League

" Here's my story: Prior to January 1974, I had been District Conservationist for the United States Department of Agriculture Soil Conservation Service for eight years..... Because of my success in Indiana I was asked to transfer to Athens County, Ohio. ....I was introduced to the outstanding people of Shade, Ohio and the fine community of Shade.....Since my wife and I are 'country folks' we only looked in the Alexander School District area. ... We just started driving the County and State roads that radiated out from Athens. In the process we went down State Road 33 and up the hill past Young's and turned left at Sam Stalder's. Orville Skinner was doing something by his house he owned and had left to move into a doublewide trailer a short piece from his old house. We just stopped to ask Orville if he knew of any houses for sale along his road. He said, "This one is not necessarily for sale, but I'll sell it if you're interested. I asked him how much he wanted for the place and he said \$12,500. I asked if I could look the place over and he said I could. It was an old house with hand-hewn rocks for the foundation except the small area where Orville had fixed in to a basement to install a gas furnace. The bottom of the house was made of hand-hewn logs.....We bought the house and fixed it up, but that wasn't what was important to this tale. What is important is that Joe Pedigo picked up trash on Angel Ridge and I asked Orville Skinner about trash pickup and Orville said a guy would be coming up Angel Ridge about 10:00 am Saturday morning. At 10:00 on Saturday I was standing in front of my house and I flagged Joe Pedigo down. Now, I'm sure everybody around Shade, Ohio knows Joe Pedigo so they know Joe is as talkative as I am. Joe and I talked for an extended period of time and Joe and I 'hit it off' as they say and he invited us to the championship game of the Biddy League Basketball Tournament at Chauncey. Freddie Kane, Orlie Saylor and Herschel LeMaster and others were on that team, and Shade beat Logan's All Star Team and I was 'hooked'."

## Rhine River Valley in Germany

The Shade-Lodi History and Genealogy program at the April meeting was James Stewart speaking about the Rhine River Valley in Germany. James is an Athens native who lives part time in Wiesbaden, Germany. His presentation began with a movie, which was a helicopter aerial tour of the Rhine River.

Germany, officially The Federal Republic of Germany, is a parliamentary republic located in western-central Europe and founded in 1949. Berlin is the largest city and capital of all sixteen states. Joachim Gauck is president and Angela Merkel is Chancellor.

The Rhine River, a vital waterway for transportation and an economic asset, runs through six countries, including Switzerland, France, Germany, Austria, Liechtenstein, and Netherlands. The river spans 766 miles beginning in the Swiss Alps, traveling north then west and then turning north again, ending at Rotterdam Netherlands and the North Sea. Some of the larger cities located on the Rhine are Basel, Bingen, Bonn, Cologne, and Rotterdam.

The Celts may have been the first inhabitants of Germany. The meaning of Rhine is from the celtic word Renos, which means "that which flows" or another meaning is "great flowing waters".

One tourist attraction mentioned was the Rheinfall, a 60 foot waterfall close to Lake Constance.

The "Romantic Rhine" an area between Bingen and Koblenz is popular because of the medieval castles, vineyards and high rocky cliffs. One of the legends is the story of Lorelei. There was a nymph who lived in the rocky bluff, also called 'murmur rock', above the river. With her beautiful voice, she sang to the fishermen and lured them into destruction. It is said there are many ships at the bottom of the river. There is now a bronze statue of Lorelei, keeping the legend hauntingly alive.

The Drachenfels castle was once home of a winged, fire-spitting dragon that was killed by Siegfried. There is also a story of The Seven Mountains. Long, long ago, the Rhine overflowed and caused great concern to those who lived near the Eifel Mountains. They needed help and sent for help from the Giants. They wanted them to dig through the mountain, to stop the flooding. One day the Seven Giants came. They had enormous tools and did as they were asked. The Rhine River was changed. The seven great mounds of dirt and rocks were so high, that they became the Seven Mountains.

The Rhine Valley has a wide variety of wines, especially white Riesling wines. But it was also mentioned that a very famous red Pinot Noir wine is produced in the little village of Assmannshausen.

Guests at the meeting were David and Barbara Markwitt Love of The Plains, OH. Barbara was born in Bingen and the couple lived in Wiesbaden. James and his wife and the Loves plan to get together to share their German ties.

# March 12, 2014 Minutes

- Pledge of Allegiance was led by Pat
- Minutes of the February 12 meeting were reviewed. Ray Baker moved to accept them as presented, Peggy Grueser seconded the motion, all in favor.
- Guest Patrick Neptune-Ceran attended the meeting. He made a request to rent the Center with the idea of offering the community Adult Professional Wrestling- a family friendly type of entertainment. He stated that he would be covered by insurance, provide EMS services, his own PA system and ring. Shows would be about six hours in duration. Crowds not expected to exceed 300 spectators. He would present one Saturday per month. There was discussion about the possibility of allowing this type of activity. Malcolm moved that we allow a one month trial, pending the findings of reference checks. Ray seconded the motion, the motion passed with one vote of opposition.
- Alex presented the treasurer's report - Checking account balance: \$77,243.59. He reported roughly \$4000.00 income, and \$2900.00 expenses. Expenses include \$750.00 to Matthews Ins. for liability coverage, AEP bill, water bill, and the repair of the convection oven (\$600.00 to Twin Oaks), printing of new checks. Alex reminded the membership that the Levy money has expired for the year.
- Corresponding Secretary, Fran, shared there was little to report this month.
- Maintenance Committee: we received a donation of a printer/copier from Twin Oaks. Boiler checks and adjustments had been made; replacement of one halogen bulb on rooftop sign and lights over the Sr. entrance, modification of light switches in Sr. room are planned for the near future.
- History group reports that Ada Woodson Adams will be speaking about Underground Railroad Systems of our area.
- Senior Association - will be having a soup dinner
- Pam Bond, of Lodi General will be using the Center's gym to serve food for the Lost in Lodi patrons (close hall doors – rest rooms NOT available.)
- A lengthy discussion about the possibility of hiring James Pascol to do grounds keeping work over the summer. He provided snow removal three times this winter. This item will be tabled allowing us to gather more information (is he insured, what would he charge, etc)
- Also up for discussion: The possibility of moving the photographs of area Veterans to the gymnasium, perhaps displaying them under the balcony. Another option is to have them copied, and display in both the cafeteria and the gym.
- There has been another occurrence of the bathroom windows being left open, which could allow intruders easy access. A possible "fix" would be to install screens over them.
- The question of keeping the bleachers in the gym was raised. Most years, they must be entirely removed for two events. This is a very labor intensive effort, and the risk of injury to those moving them is high. There were suggestions of keeping them, getting rid of ½ of them, getting rid of all of them, or dismantling to one bleacher high. Norman moved that we eliminate all of them, Rose seconded, the motion carried.
- Status of By-Laws and Standing Rules Review Committee – Marvin stated that the committee was nearly ready to report and recommended that any changes/proposals be included in the April newsletter.
- Estimates on the replacement of the front doors are still at a standstill. We will notify those that have shown interest that their estimates must be submitted by the April 9<sup>th</sup> meeting, as moved by Robin, seconded by Heidi. To date, only Hoon has given us an estimate.
- Valentine Dinner report – about \$2566 income, yielding about \$1000.00 profit.
- The Athens Foundation luncheon was very successful. There were 13 attendees, the Mayor of Athens secured membership.
- Kitchen cabinets have been ordered from Lowes. Stainless steel tables ordered as well. There will be re-arranging of existing equipment, painting, etc. in the kitchen area.
- As of this meeting, holding of the Chinese Auction remains in question. A decision will be made very soon.
- Robin moved that the meeting be adjourned, Heidi seconded. Motion carried

# April 9, 2014 Draft Minutes

- Members present: Ray Baker, Marvin Marty, Heidi Marty, Steve Kane, Richard Grim, Glenna Grim, Gail Jordan, Manuel Grueser, Bette Sloane, Grace Dorst, Fran Moxley, Richard Coe, June Coe, Karen Jones, Walter Jones, Robin Krivesti, Roberta Henderson, Malcolm Grueser, Jerry Foster, Alex Couladis, Peggy Rist, Pat Davidson, Teresa Winning, Debbie McAdoo
- Pat Davidson led the group in the Pledge of Allegiance.
- Minutes of the March 12<sup>th</sup> meeting were reviewed and accepted as corrected, Motion by Ray, second by Peggy Rist.
- Alex Couladis reported that the checking account balance was \$72,176.95. There was <\$4853.30> income for the month, <\$1921.67> Year to Date. This is due largely to the Township funds being exhausted and the association is currently paying all utilities, building repairs, and insurances. Edna Frost advised Alex that our investment funds gained \$500.00 (1% of invested amount) in the most recent quarter.
- Corresponding Secretary, Fran sent eight Thank you cards, one Sympathy card and five New Member cards during the month.
- VP, Peggy, handed out a calendar with upcoming events, discussion, additions and edits were made.
- The Maintenance committee reported that modification of light switches in the Senior's room were forthcoming, Ron Hedrick will be installing the outside lights at the rear of the building, lights in Lady's restroom will be replaced, as well as a new toilet seat .
- Grounds keeping issues: James Pascol offered to mow for \$140 per mowing, using our equipment. Accepting this type of offer would make it necessary for us to hire him as an employee of the center, IRS implications, etc. Discussion for a campaign for more volunteer workers for the summer by way of the newsletter and phone calls. Heidi and Karen volunteered to initiate the phone calling requests. Marvin moved, a second by Robin, that we go forward on the purchase of a weed kill pump, not to exceed \$500.00, the motion carried. Heidi also offered the assistance of the Saddle Slickers 4-H club with the weeding and up keep of a flower bed on the grounds.
- The History Group will have James Stewart speak on "Germany's Rhine Valley" April 15<sup>th</sup>.
- The Seniors will be taking a bus trip to the Ohio Valley Opry.
- Items for the upcoming newsletter need to be to Rhonda Meeks by April 21, 2014
- There was a motion from Robin, seconded by Fran to reopen the decision to eliminate all of the bleachers in the gymnasium. The discussion included modifying them, keeping only ½, and the possibility of using folding chairs. A motion from Heidi, seconded by Fran was made to have ½ of them returned to the gym after the Alumni Banquet, and then have the discussion pick back up at the regular May meeting.
- The Center will sponsor a Community Yard Sale, June 14, 2014, 9 a.m. to 3 p.m. This will be advertised in the next newsletter.
- Patrons have been abusing the parking area in front of the cafeteria by parking in the front yard, and deep onto the adjoining property of Dan and Janet King. There was a motion by Theresa, second by Heidi to install posts with caps and chain on the Center's side of the drive way, and an offer to do the same on the King property if Dan is in agreement.
- Gail will update the sign in the front of the building advising the community of Lodi Clean-up Day, April 12, 2014.
- A question came before the membership regarding parking PICK-UP trucks on the basketball court and on the baseball field during the Lost in Lodi event. By consensus, agreement on the ball court, "no", for the baseball field, as the ground is too wet and soft.
- We are experiencing continuing problems with the gates between second and third floors being left unlocked. Comments were made that the locks were extremely difficult to close. Possible options to correct this: lock the 3<sup>rd</sup> floor only, making certain that rooms on the second floor that need secured are locked when not in use; and/or attempt to make gates easier to lock on the second level. This will be revisited at the next meeting.
- The request to rent the facility for Professional Adult Wrestling was brought back to the floor. Pat read a response from folks at Hocking College that had hosted similar events. They cited the pros and cons that they had experienced. After discussion, a motion was made by Teresa, seconded by Steve to decline the request, motion carried.
- By-Laws and Standing Rules Review Committee presented the proposed changes. Discussion will be held at the May meeting for membership vote.
- Estimates for replacement of the front doors have been submitted by Hoon Inc. (\$16,473); Thomas Bros. (\$24,166.00), upon payment in full, \$1000.00 donated back to the Center; and Rick Collins (18,900). The decision on this is tabled pending clarification on the bids.
- Kenny Meeks has agreed to hang the new wall cabinets in the kitchen area.
- The fire department approached Marvin, asking if the Center would allow the use of the building for training purposes on April 16. They have used the building in the past. "Yes" by general consensus.
- The Homeschoolers have completed their time with us for this year. Our Treasurer recommends that we not rent to them again, as tracking payments from them was not an easy task (partial, individual monthly payments rather than total monthly amount). Theresa moved, Ray seconded that we table the discussion until later regarding future rental to the group.
- Robin reported that the Easter Egg Hunt had 41 children in attendance. There was \$456.00 in expenses, \$89.06 received in donations.
- Ray announced that there will be the annual car show June 7-8, Carthage, and that he and others from near-by communities "jam" the 4<sup>th</sup> Tuesday of each month at the Chillicothe VA center, all are invited to attend.
- Ray moved that the meeting be adjourned, Alex seconded.

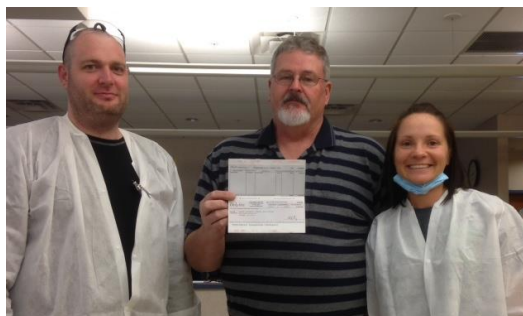
