Cruisin' in to Shade

For the first time the Shade Community Center is hosting a summer cruise-in. Several times in recent years antique tractors and sometimes other vehicles have made their presence known in Shade at the Jerseyville Festival. And a couple times King Midget cars have stopped here as part of their jamborees.

Saturday, July 9th all vehicles are welcomed to our "Burger 'n Fries Cruise-in". See flyer and other activities that day on page 9.

According to events committee chair Fran Moxley, any motorized vehicle is invited to participate in the cruise-in. Registration for the cruise-in begins at 10:00 am, and those registering their vehicle receive a free t-shirt.

Flea market and yard sale vendors will also be set up

that day starting at 9:00 am. Vendors must register on arrival and for this day only can set up outside on the lawn for free or pay \$5 to set up inside the gym. The shelter house is reserved for regular community market vendors.

Lunch is planned starting at noon with burgers and fries — hence the name of the cruise-in. Cherry pies and other desserts, drinks, and hot dogs for the kids will be available too.

Remember Then will be performing their classic 50s and 60s rock and roll oldies on the outdoor stage beginning at 2:00 pm to top off the day.

All attending the cruise-in and other activities are encouraged to bring their own chairs and blankets and enjoy the music of this free concert.

SCCA May 11, 2016 Meeting Summary

President Pat Davidson called the meeting to order at 7:05 pm. Alex Couladis moved for approval of the April meeting minutes as written; Grace Dorst seconded. Minutes approved.

Treasurer Alex Couladis reported net income for April of \$688.05, checking account balance of \$12,911.25, and Emogene Coen investment had increased to \$54,439.00. Corresponding Secretary Teresa Winning reported seven additional memberships bringing total members 244 for the year. Vice President Fran Moxley distributed the events calendars for May and June. Live Healthy Appalachia is offering four weekly healthy cooking classes beginning June 21. Tammy Foster said that the COAD summer feeding program will begin on June 15, meeting this year for seven weeks on Wednesdays and Fridays from 10 am to 12:30 pm.

Highlights of maintenance report included locating the bench that Barbara Dougan Brake had donated for the walking path and return of the trophy case to the first floor hallway. Also Twin Oaks had repaired the chiller for the walk-in cooler and enlarged kitchen gas piping.

Dr. Jamie Linscott was to present "Appalachian Culture" at the May history meeting. The annual meeting of the Athens County Historical Society will be June 12 at the Center with the SCCA cooking the meal. George Benz announced that about sixty people attended the Trustees Dinner in April, which earned the Seniors \$990.

New Business: Pat introduced Frank Cargould who has accepted appointment to the Executive Committee.

Fran proposed getting an annual food service/health department permit, for a one-time application fee of \$239, then costing \$512 per year. Fran moved to purchase and install a 3-bay sink that is required for this permit; Tammy seconded the motion; motion carried.

Pat reported that the trustees have no objection to the bandstand/gazebo but want to see more detailed plans and also want the two basketball poles and hoops replaced. Jerry briefly described the plans for the 20 feet by 30 feet bandstand/gazebo, and funding possibilities were discussed.

Old Business: Optional evenings to offer the exercise class were discussed. Tammy noted that a \$1000 treadmill and \$700 elliptical had been donated.

Fran reported a successful first fish fry. She also said that one had paid to participate in the Shade Community Market twice weekly. Gail reported that no further progress by the committee on the 2015 financial review.

Walter moved to adjourn; Alex seconded. Meeting adjourned at 8:50 pm. 20 members attended (7 officers/board).

SCCA June 8, 2016 Meeting Summary

President Pat Davidson called the meeting to order at 7:03 pm. Marvin Marty moved for approval of minutes of the May meeting with corrections; Tammy Foster seconded. Minutes approved.

Treasurer Alex Couladis reported -\$1,228.56 as net income for May, and he distributed a reconciliation showing transactions for the Coen bequest since it was received in March 2013. Corresponding Secretary Teresa Winning reported sending 6 get well cards and return of one former member. Vice President Fran Moxley distributed the events calendars for June and July.

Maintenance highlights included installation of several more exit signs and emergency lights, fixing the condensate line for the walk-in cooler, installation of the triple sink in the kitchen, and relocation of the Brake walking path bench to near the bridge.

History meeting on June 21st will be a tour of the Southeast Ohio History Center. George Benz reported that representatives of the Seniors had a follow-up meeting with the Athens County Commissioners regarding their grant proposal.

New Business: Several recent incidents prompted discussion of security cameras. Alex suggested that Jerry Foster research security camera systems. Limited Use Limited Access (LULA) elevators were discussed as a possibility to improve handicapped access to upper floors. Alex suggested getting pricing for various configurations.

Old Business: Megan Buskirk from the Athens Health Dept. explained expectations regarding treadmill and elliptical exercise equipment that had been purchased with grant funds and donated. Alex moved that the exercise equipment be placed initially in the present computer room and that Gail be authorized to move computers to the second floor office. Fran seconded the motion, which carried.

Fran had announced at the executive committee meeting that the Coen bequest agreed to fund \$5000 toward the bandstand gazebo. The \$11,800 CD would then fund most of the remaining estimated cost with donations and fundraising to provide the balance needed. It was suggested that this project be dedicated to Phil and Ellen Goldsberry since most of this CD comprised donations from them. Fran moved to proceed with the project, once the township trustees have reviewed more detailed plans, starting with the \$16,800 and using donations and fundraising for the balance necessary. Tammy seconded the motion. Motion carried.

Heidi and Marvin Marty reported that the big bookcases have been moved to the new library room, and they expect all books out of the present room before July.

Teresa reported \$380.78 income from the yard sale. Fran reported another fish fry scheduled for June 17th, vendors offered to set up free at the Community Market during June, and a cruise-in with burgers and fries scheduled for July 9th.

Ray moved to adjourn; Robin seconded. Meeting adjourned at 8:42 pm. (21 members attended (8 officers/board)

May 24, 2016 Executive Meeting Summary

Executive committee members Pat Davidson, Fran Moxley, Teresa Winning, Gail Jordan, Frank Cargould, Alex Couladis, Norm Shaner, and Marvin Marty were present, as was Jerry Foster who had been invited to attend.

Gazebo/bandstand: Coen bequest committee agreed to provide \$5000 toward funding. Fran suggested taking \$2000 from the Halloween fund and the Center supplying \$3000, then partially constructing. She suggested seeking grants and a fundraising effort to complete construction. Several present did not think that such partial construction was feasible or desirable. Gail suggested using one of the two CD's that we have had for several years, adding that \$11,800 to the Coen \$5000. This \$16,800 would provide most of the funds needed for construction, with an appeal for donations for the remainder. Gail also suggested that since the bulk of the funds in that CD were given by Phil and Ellen Goldsberry that the gazebo be named and dedicated to them. Pat was to contact Ellen to see if she approves of this idea. Norm suggested a dedication ceremony once construction is complete and said that he would try to get Remember Then to play.

Repairs to third floor plaster, floors, etc.: No estimate has yet been received.

Use of space in building, potential for long-term rental space: Gail noted rental rates for our last long-term renters: Tom Trantina began renting two rooms on the third floor in 2006, and he paid \$0.40 per square foot per month (\$4.80 per square foot per year, for third-floor space). Cassie Bowen began renting a second floor room in 2007, and she paid \$1.28 per square foot per month (\$15.36 per square foot per year, for second-floor space).

Jerry suggested taking pictures of the former library to advertise for rental. Marvin said that he thought that Heidi's art group and Tere Sager were willing to move their activities to the third floor. Fran wondered if space could be made available to members for lesser amounts until such time as a long-term renter wanted such space.

Handicapped access to second and third floors: Gail mentioned that a ramp could easily be built from the side to the landing of the left front double doors, and he suggested that a single straight run chair lift could then provide handicap access to the second floor of the building. Fran noted that a problem with this is that one would have to go outside and around through the cafeteria for access to restrooms.

Pat and Marvin suggested a better option might be a "Limited Access/Limited Use" elevator. Marvin agreed to contact Dave Willoughby and also Dean Kahler, who has one in his residence. Gail also is to investigate these elevators prior to the next SCCA meeting in June.

Appalachian Cultural Values

Dr. Jamie Linscott presented "Appalachian Cultural Values" to nearly twenty attendees at the May meeting of the Shade-Lodi History and Genealogy Association. Appalachia is defined politically as 420 counties in 13 states, including all of West Virginia. West Virginia and southern Ohio are known as north central Appalachia.

Appalachians are those born in the region whose parents and grandparents also were born in the region. These include 23 million people, including descendants of Cherokee and Iroquois native Americans, Spanish slaves, vari-

ous European nationalities, and freed slaves. Over eighty percent are Caucasian of English, Welsh, Scottish, Irish, German or Swiss descent.

Jamie described several common values: Appalachians have a history of needing to be independent and self-reliant and are proud of that. Their neighborliness is a sort of extended kinship network and a means of cooperative independence. Family is the central feature; some are matriarchal and some are patriarchal. She said personalism included hospitality and respect for elders, space, privacy and family. Humility and modesty are important too.

Religion is largely protestant with a "family church" even if not practiced or defined. They have a love of place where they are connected to home, family, spirituality and heritage. Appalachians have a sense of beauty toward the land and traditional arts. They are also known for their patriotism, being leery of government but also have more medal of honor recipients than any other region. Their sense of humor is typically dry, a positive coping strategy and a source of entertainment. And they are resilient.

Southeast Ohio History Center

Cyrus Moore invited the Shade-Lodi History and Genealogy Association to tour the Southeast Ohio History Center for the June meeting. The Athens Historical Society and Museum has purchased the First Christian Church building on West State Street in Athens and has begun major renovations to convert it to a regional history center. They have catalogued and moved all the collections from their former location on North Court Street. Over the next two years they will be sharing the building with the church congregation until it decides where to go next.

The church opened in April 1917, the same month as the United States entered World War I. The first exhibit planned for the center will focus on World War I and the history of the church building. The church served as cafeteria and some housing for those mobilizing for the war since the armory was not large enough.

The building is on the National Register of Historic Places. Its interior is Craftsman style and built according to the Akron plan. The left wall of the sanctuary can be raised into the ceiling (shown above Cyrus in the photo below) and acts as a very large door to open to another large room and balcony area. This door had been inoperable for about twenty years until a group of Ohio University engineering students recently repaired it. An elevator is being installed to provide easy access to all floors to those entering from the parking lot side of the building.



Cyrus led a tour of the building, showing where museum items and offices are presently located as well as



what has been, is being and is planned to be renovated. Cyrus also described projects on which he is currently working; a major one is collecting

oral histories of veterans of the Viet Nam War from southeast Ohio.

STERN MR. RUTH WAS TRUE EDUCATOR

I recall an incident where I could have sworn Mr. Ruth had eyes in the back of his head. I had left my seat to sharpen my pencil in the crank-style pencil sharpener that was mounted at the edge of the big blackboard behind Mr. Ruth's desk. Mr. Ruth was seated at his desk and as I was returning to my seat, I pretended (for the class to see) to blow the pencil shavings onto Mr. Ruth's balding head. He reacted immediately with his deep voice, "Tracy, don't you EVER do that again!" And I didn't...I was so embarrassed.



It was not uncommon to have lots of homework in Mr. Ruth's class. I can still see the pages and pages of math workbook fractions...and this was before the calculator. Even during the Christmas break, I was assigned to do a report on the country of England, much of it retained to this day.

Mr. Ruth's son, Brill, was a student in that same class that year but caught no breaks from his Dad. Even though Mr. Ruth was a strict disciplinarian, his students were able to see his compassionate side and even an occasional smile when they surprised him one day with a fruit roll. Every student, simultaneously, rolled an apple up the aisles between our desks toward Mr. Ruth because we loved him and respected him as our teacher.

That sixth grade classroom was on the second floor at the top of the north stairs of the Shade school building. Mr. Ruth's daughter, Brenda, with her husband Gail Jordan, have transformed her father's classroom into a treasure trove of Shade historical memorabilia as an important part of the, now, Shade Community Center. The establishment of the Center was due to visionaries such as Roger Hawk and others. The alternative was to demolish the building. What a mistake that would have been.

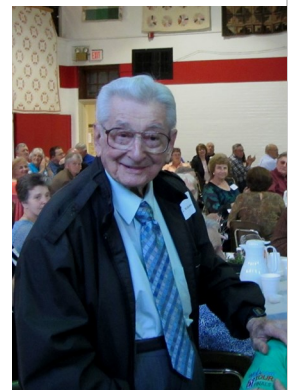

Changes Are Coming

to the Shade Community Market Beginning, Saturday, July 9, 2016

Thanks to all of you who have bought plants and vegetables at the new Shade Community Market.

The market's hours will be changing to 10 a.m. to 1 p.m. every Saturday, beginning July 9, 2016. All vendors of locally grown items, freshly prepared foods, and personally crafted products are invited to sell at the Community Market for free through the summer. You are welcome to come one time to test out your products on customers and then return to sell as many times as you would like.

All local growers, producers, and crafters are welcome to set up at the Shelter House area. Vendors are asked to sign in with Gini Coover between 9:00 and 9:30 a.m. to determine a location to set up. Room will be available under the Shelter House until it is filled. Then people can set up near by.

All products regulated by the State Department of Agriculture, USDA, or County Health Department, must meet those requirements to be sold. Any required licenses must be available for public display.

The second Saturday of each month, beginning July 9th, there will also be a flea market and special events held at the Center to increase customer traffic.

The Tuesday market will be discontinued, but those loyal customers who wish to continue to purchase plants, vegetables and meat chickens raised on pasture, can contact Gini Coover at 740-594-4147 for directions to her farm. She will be open to sell each Monday and Thursday at the farm, 3-7 pm, or at other times by appointment only.

The Shade Community Center encourages economic development at the grass roots level by connecting vendors with local community members. If you have any ideas on how to expand these efforts, bring your ideas to Gini at the Community Market or contact Fran Moxley, 740-985-4492.

Bread Pudding

8 slices of bread

½ Cup sugar
3 eggs
¼ tsp. salt
4 cups milk
