**SCCA August 10, 2016 Meeting Minutes**  
(APPROVED 9-14-16)

Members present: Pat Davidson (P), Fran Moxley (VP), Gail Jordan (Rec. Sec.), Alex Couladis (T), Frank Cargould (BM), Marvin Marty (PP), Ralph & Amy Calvert, Walter & Karen Jones, Roberta Henderson, Heidi Marty, Peggy Rist, Tere Sager, Roger Hawk, Steve Kane, Brenda Ruth, Tammy & Jerry Foster, Jack Malloy, Charlotte & George Benz, Grace Dorst, Pam & David Hatfield, Betty Rosser (20 members+ 6 officers/board = 26)

The regular monthly meeting of the Shade Community Center Association was held on Wednesday, August 10.

Fran Moxley moved to suspend the agenda and move to pertinent business of the day on point of order that entire body had been out of order after December, 2015 since Teresa Winning had previously resigned as chair of the library and position was filled not following standing rules of the organization. Following discussion, Alex moved to talk to Teresa to see if she is willing to reconsider being chair of library. Motion carried with no negative votes. Following discussion of completing the move of the library and temporarily moving exercise equipment to the former library room, Alex moved to relocate the exercise equipment and post schedule to comply with requirements of the Athens County Health Department, which had donated the equipment. Motion carried with no negative votes. Fran then moved to re-establish the order of the day, which passed with no negative votes.

Minutes of the July 13, 2016 regular meeting were distributed. Fran moved for approval of the minutes as written. Minutes approved. Treasurer Alex Couladis reported that levy revenue had been received from the township trustees and balance in checking account was \$19,190.87. Maintenance committee report was distributed and then placed on file.

Security system options, including signage, were discussed. Pat Davidson requested a committee, with Steve Kane, Walter Jones, and Jerry Foster agreeing to serve. Roger Hawk moved to approve \$200 for the committee to use at its discretion. Motion carried with no negative votes.

Pat Davidson reported that the Lodi Township trustees mandated that the Pratt's Fork bell be left where it is and not made part of a bandstand gazebo. They also stipulated that any future plans for a bandstand gazebo at another location be drawn by an architect and submitted to them for approval. Fran moved to reconsider the location. Motion carried with no negative votes.

Committee to review the constitution and by-laws was appointed: Fran Moxley, Marvin Marty, Pam Hatfield, George Benz, and Heidi Marty. Peggy Rist, Karen Jones, Tammy Foster, and Amy Calvert volunteered to serve on nominating committee for 2017 officers.

Meeting adjourned at 8:25 pm..

The regular monthly meeting of the Shade Community Center Association was held on Wednesday, September 14.

Guests Katelyn Emter and Brian Berthold representing the Ohio University Archery Club made a request to see if it would be possible to use the gymnasium to practice archery for the indoor season. Following discussion Fran Moxley moved to offer temporarily use of the ball field free of charge and to consider indoor practice once proof of insurance is received. Motion carried with no negative votes.

Minutes of the August 10, 2016 regular meeting were distributed. Fran Moxley moved for approval of the minutes as corrected. Minutes approved. Treasurer Alex Couladis reported that \$500 had been received from the Shade Senior Citizens Association to assist with purchase of a security system. August report showed net income for the month of -\$444.03;. Maintenance committee report was placed on file. Major items noted: fire alarm system is now operational, and all items on fire inspection list have now been addressed.

Jerry Foster and Walter Jones reported on security system suggested by RC Barnhart. Following discussion Fran Moxley moved to authorize purchase of a 6-camera system once all locations are determined, keeping total as close to \$700 as possible. Motion carried, with no negative votes. Because of recent missing items, Roberta Henderson moved to keep the kitchen storage room locked and to re-key the door with "do not duplicate" keys. Motion carried, with no negative votes.

Constitution & By-laws committee presented suggested revisions, which were published in the September-October newsletter and which will be discussed at the October meeting. Item mentioned to add was requirement to run for office.

Jerry Foster reported plans for Jerseyville Festival and passed around a volunteer sign-up sheet. Heidi Marty moved to purchase 2 picnic tables, then withdrew the motion. Fran Moxley moved to research purchase of 2 light-duty picnic tables and light-duty pop-up canopies for additional seating outdoors at the festival, with Executive Committee authorized to finalize approval. Motion carried.

### September 27, 2016 Executive Meeting Minutes (APPROVED 10-12-16)

Pat Davidson, Fran Moxley, Gail Jordan, and Marvin Marty were present.

Recycling: Roger Bails of Athens-Hocking Solid Waste District informed Pat that it would reimburse SCCA for concrete or belting to put under the recycling containers to facilitate cleanup of broken glass. None present were convinced that location at end of basketball courts was desirable as the permanent location. It was decided to relocate the recycling containers to along the East Street entrance between Old US 33 and the shelter house (as a trial prior to the Jerseyville Festival); decision to pave or place belting is delayed to see if this seems to be suitable for a permanent location.

Security cameras: Jerry Foster and Walter Jones have selected a system and sent information to Steve Kane, but as of time of meeting had not received his response.

Archer Club practice in gym this winter: Pat had sent email but had not heard back.

Handicap access to second and third floors: The stair lifts (for which Gail had received quotations from Arrow Lift in Columbus) would help but would not provide true handicap accessibility (ADA compliance). Limited Use Limited Access elevators and other lifts that could be used by those in wheel chairs are much more expensive. Fran said she would try to find again information on a low-cost lift for installation on the outside of the building. Grant funding needs to be explored.

Custodian: Need to settle up with Sean Bobo; he never filed for last 20-1/2 hours that he worked. Fran agreed to contact Alex to pay Sean. Pat noted potential applicant for the job, Jen Pae.

Pat announced that Roberta Henderson had called to tell us that Christ the King University Parish in Athens had stackable chairs from its Fellowship Hall that they were willing to give to the Community Center, if they were picked up by the beginning of the following week.

that was donated by All Power. Charlotte Benz won the painting of the Blackwood Bridge that was donated by Joni Carrington. Bev Hornsby



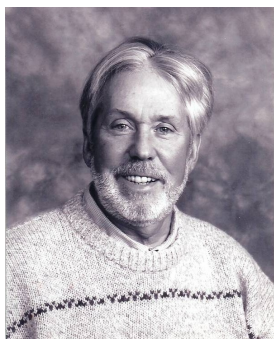
won the \$25 White's Mill gift certificate.

## "History Pages"

### The Sharecropper's Third Son

Tracy Hanning, who has contributed several stories for the newsletter, recently gave the history group several CD's containing many more stories of his. He entitled this 230 page collection of memoirs "The Sharecropper's Third Son: From the Cow Barn & the Schoolhouse to the Rooftop". To give you a taste of his memories and thoughts, following is a short excerpt:



#### The Birthplace of Alton

My father, Alton Hanning was born in that log cabin in Lodi Township in 1911. His father was John Charles Hanning. John's father was Charles Wilson Haning, the youngest child of John Haning who married Delilah Reeves. John, who was the eldest son of James and Gertrude was perhaps the next to inherit the Lodi land that wrapped around the Haning Cemetery and was likely the builder of the log house where my father was born. James and Gertrude also produced Ira Z. who was

a Free Will Baptist Minister who would have been 47 when the Haning Free Will Baptist Church was built. Ira Z. Haning later was a founder of Rio Grande College in Gallia County, Ohio in 1875.

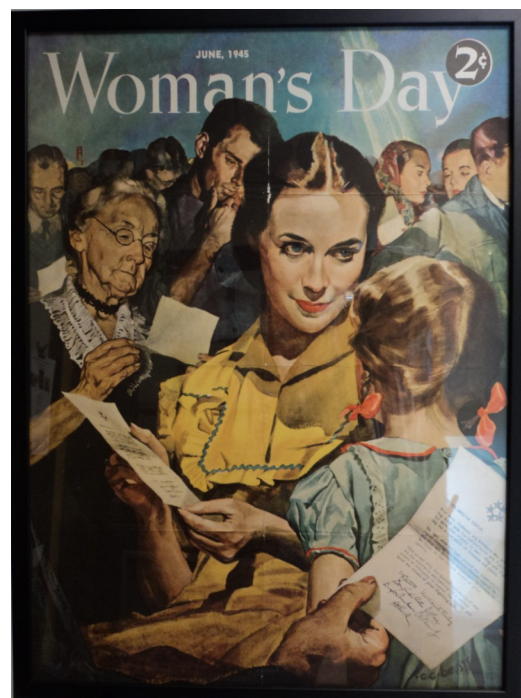
John and Delilah, my great, great grandparents, had 10 children with only 4 living to adulthood. The youngest of the family, Charles Wilson lived in a newer house just northwest of the log home where Alton was born. The Charles W. Haning homestead was the site of a large family reunion in 1917. He was struck by an automobile in 1936 as he was crossing Richland Avenue in Athens and died several days later. This homestead burned to the ground around 2002. He was a widower and is buried in the Haning Cemetery near his homestead. Charles Wilson Haning and his wife, Sarah Elma Radford, named one of their sons after his father, John Charles Hanning. Upon taking Mazie Gilkey as his bride and setting up housekeeping in the old log home around 1910, they brought seven children into the world over their lifetime. Around 1915, an opportunity allowed them to move a couple of miles up the road to Pleasanton to the Doc Bean homestead.

### Woman's Day Posters

The Shade-Lodi History & Genealogy Association now has in its collection four posters of Woman's Day magazine covers from the 1940s.

Miss Margaret Bridge taught first graders for fifty years, from the early 1930s to the early 1980s. She taught at the New Marshfield elementary school for over forty years. In the 1940s Woman's Day magazine cost 2 cents or 5 cents and posters of the covers could be purchased for 10 cents, which Miss Bridge did each month to use on the bulletin boards in her room. After her retirement she lived in New Marshfield and traveled around the world.

Miss Bridge's sister gave these posters to SCCA member Nancy Nottke, who donated them to the history group. They have been professionally framed for display.





### The Quilters



Lois Swartz Bigley recently sent this photo to Brenda Ruth. The Shade quilters are, left to right: Gertrude Douglas Deweese, Bernice Randolph Swartz Meeks, Leola Follrod Swartz, and Myrtle Kelley Stover. The photo was taken for a special interest article in the 1970's for either the Athens Messenger or the Athens News.

According to notes on the back, Gertrude died in 1997. Leola, Bernice, and Myrtle were still quilting in 2001 at the newly opened Senior Center in Athens. Leola and Bernice were over 90 then and are now deceased. Myrtle, who is now 98, visited during the Jerseyville Festival this fall.

### An Old Copper Kettle

Shortly before the Jerseyville Festival, Jane Erwin delivered a copper kettle, base and paddle that her mother Eleanor Walters McLead donated. These items had been given to her by Mary and Anna Weisenbach.

Eleanor lived on Bucks Lake Rd. from 1954 to 1983.

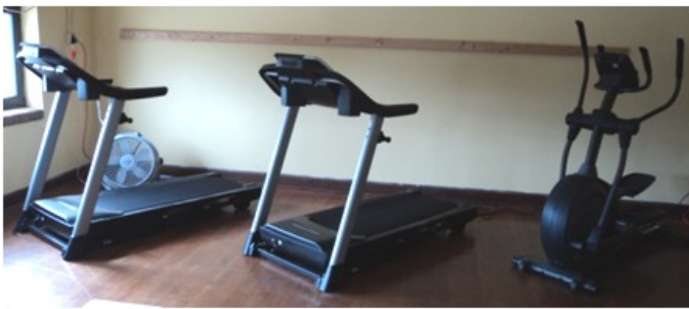

## Cook's Corner

### *Black Bean and Avocado Salad*

6-8 servings

Ingredients:

- 2 cans low sodium black beans
- 3 cups corn kernels (fresh, frozen or canned)
- ½ cup diced red onion (about ¼ of a medium onion)
- ¼ cup finely chopped cilantro
- ¼ teaspoon garlic powder
- 1 lime, juiced
- 1 lemon, juiced
- 2 large avocados, cubed (optional)
